# **Appointments to MPF Schemes Advisory Committee and MPF Industry Schemes Committee**

The Advisory Committee is a statutory committee established under the Mandatory Provident Fund Schemes Ordinance (MPFSO) (Cap. 485). It advises the MPFA with respect to the operation of the MPFSO as well as the effectiveness and efficiency of the MPFA.
